THIS IS WITH REFERENCE TO THE ABOVE TENDER DOCUMENT NO: CE/0043 DATED 02ND JULY 2024.

PLEASE NOTE THAT THE **SUB CLAUSE 12.2.1.** OF THE **CLAUSE 12.2. BID SECURITY GUARANTEE** OF THE ABOVE TENDER DOCUMENT (**TENDER REF. AG/11/2024**) IS AMENDED AND REPLACED AS FOLLOWS;

12.2.1 PRIOR TO THE BID OPENING, ALL BIDDERS SHALL ESTABLISH A BID SECURITY GUARANTEE FOR **UNITED STATES DOLLARS ONE THOUSAND ONE HUNDRED (USD 1,100/=) OR AN EQUIVALENT AMOUNT IN SRI LANKAN RUPEES THREE HUNDRED FORTY THOUSAND EIGHT HUNDRED (LKR 340,800/=)** FOR THE TENDER UNDERTAKING THAT THE BID WILL BE HELD VALID FOR THE SPECIFIED PERIOD AND THAT THE BID WILL NOT BE WITHDRAWN DURING THAT PERIOD. SUCH SECURITY SHALL BE IN THE FORM OF A BANK GUARANTEE ISSUED/CONFIRMED BY A LICENSED COMMERCIAL BANK IN SRI LANKA OR A BANK BASED IN ANOTHER COUNTRY BUT THE GUARANTEE CONFIRMED & ASSURED BY A LICENSED COMMERCIAL BANK IN SRI LANKA, IN FAVOR OF CEYLON PETROLEUM CORPORATION AND PAYABLE TO THE SAME ON DEMAND.
