- (A) PLEASE NOTE THAT THE DELIVERY PERIOD OF THE ABOVE TENDER HAS NOW BEEN EXTENDED. ACCORDINGLY, THE DELIVERY PERIOD SHOULD BE AMENDED TO READ AS **"DURING THE PERIOD OF TEN (10) MONTHS COMMENCING 01ST SEPTEMBER 2018 TO 30TH JUNE 2019"** INSTEAD OF **"DURING THE PERIOD OF EIGHT (08) MONTHS COMMENCING 01ST SEPTEMBER 2018 TO 30TH APRIL 2019"** WHEREVER IT APPEARS IN THE TENDER NOTICE.
- (B) FURTHER, THE CLOSING OF OFFERS HAS BEEN EXTENDED UP TO 1200 HRS SRI LANKA TIME ON TUESDAY 19TH JUNE 2018 AND THE OFFERS NOW SHOULD BE DEPOSITED IN THE TENDER BOX BEFORE 1200 HRS ON TUESDAY 19TH JUNE 2018. ACCORDINGLY, THE CLAUSE 2.25 SHOULD BE AMENDED TO READ AS QUOTED BELOW;
