To be eligible for awarding the Contract, the successful bidder shall not have been blacklisted and shall have complied with the eligibility and qualification criteria stated in the Bidding Document.

SECTION 1 - INSTRUCTION TO BIDDERS (ITB)

1.1 Introduction

- 1.1.1 The Chairman, Departmental Procurement Committee (DPC) on behalf of the Ceylon Petroleum Corporation (hereinafter referred to as CEYPETCO) invites sealed bids from eligible and qualified bidders for "Hiring of a vessel for a period of twelve (12) months for Maintenance and Emergency Response Work connected with the Single Point Buoy Mooring (SPBM), installed off-shore Colombo Harbour"
- 1.1.2 The intended Service Period is twelve (12) months and service will be obtained when and where required.

1.2 Issuing of Bidding Document

1.2.1 The original Bidding Document could be obtained from the undersigned on submission of a written request (the request letter shall be signed and issued by an authorized person), during working days from 0900 hrs. to 1500 hrs. up to 11.03.2025 upon payment of a non-refundable Bidding Document fee of Rs. 10,000.00 (Rs. 8,267.88 + 2.5% SSCL + 18% VAT).

1.3 Documents and Details to Accompany the Bid

- 1.3.1 All Bids should contain adequate particulars as required under the Bidding Document. Failure to furnish the following documents and details before the closing of Bids may result in the Bid being rejected. All documents shall be furnished in English Language.
 - 1.3.1.1 Bids duly completed according to the format of the Offer Sheet in the Schedule B (Format of Offer) should be submitted together with the duly completed and certified declaration form in Schedule A: Form of Bid.
 - 1.3.1.2 Detailed Bid with all inclusive rate (including fuel cost) in Sri Lankan Rupees per day/hrs. for the period of the contract (Please see Section 2- Sub Clause 2.5).
 - 1.3.1.3 Bidder shall indicate in the Bid:
 - a) Ownership of the vessel with documentary proof including purchase agreement if any.
 - b) Whether Bidder is a Charterer by demise of the vessel (with signed copies of relevant Charter Parties).
 - c) Whether Bidder is the Manager of the vessel with documentary proof.
 - 1.3.1.4 Specifications of the vessel offered, together with all certificates to establish that the vessel offered conforms to the specifications stipulated in 'Section 3: Specifications of the Vessel'. All questions of the offer sheet must be answered without any amendments or deletions to the items or CEYPETCO requirements/ specifications mentioned therein and submitted with the Bid.
 - 1.3.1.5 Valid certified copies of all certificates required as per item 10A of 'Schedule B: Format of Offer' and general arrangement drawings of the vessel shall be submitted along with the Bid. Certification of validity to be by representative of classification society who shall have full time membership of International Association of Classification Societies (IACS) in which vessel is registered as referred to in item 9A of 'Schedule B: Form of Offer'.

- 1.3.1.6 The audited final accounts for the three financial years commencing from 01st of January 2021 to 31st December 2023 or 01st of April 2021 to 31st March 2024 (Whichever applicable).
- 1.3.1.7 A copy of the valid certificate of Registration (PCA 03) issued by the Registrar of Companies together with the bid.
- 1.3.1.8 Any other documents deemed to be important.

1.4 Submission of Bids

- 1.4.1 The Bid prepared by the Bidder, as well as all correspondence and documents relating to the Bid exchanged by the Bidder and the CEYPETCO shall be written in English Language. The officer who signs the Bid (authorized officer) should have proper authority from the respective Bidder or the Principle for signing all documents related to the Bid. The authority shall be in the form of a Board Resolution or documented decision of the partners in a partnership as the case may be.
- 1.4.2 Completed offer sheet ('Schedule B: Format of Offer') properly signed and sealed/stamped in each page will be treated as the main part of the Bid together with other details requested in Clause 1.3 in Section 1:'Documents and Details to Accompany the Bid' in respect of this Bid. In addition, all pages in all other documents submitted with the bid shall be initialed by the authorized officer of the Bidder.
- 1.4.3 Bids shall be submitted in duplicate as per the conditions specified in this Bidding document at the address specified in Sub Clause 1.6 of Section 1. The Original and Duplicate of the Bid should be placed in separate envelops marked 'ORIGINAL' and 'DUPLICATE' respectively. Both envelopes should be enclosed in one securely sealed cover and marked 'Hiring of a vessel for a period of twelve (12) months for Maintenance and Emergency Response Work connected with the Single Point Buoy Mooring (SPBM), installed off-shore Colombo Harbour" on the top left hand corner with the statement 'Do not open before 1400 hrs. on 12.03.2025.

1.5 Period of Validity of Bids

1.5.1 Bids shall be valid for a minimum period of Ninety One (91) days from the closing date of the Bid (i.e. 11.06.2025) with the provision to extend if necessary. The bids valid for a shorter period will be rejected as non-responsive.

1.6 Closing of Bids

1.6.1 Bids sealed and addressed as aforesaid shall be sent under registered cover to reach,

not later than 1400 hrs Sri Lanka local time on 12.03.2025. If the Bidders or their representatives choose not to send their bids under registered cover they could deposit such bid in the Bid Box provide for this purpose at the office of the Manager Procurement & Stores, in the above address.

1.6.2 Any Bid received after the deadline prescribed above will be rejected and returned unopened to the Bidder.

1.7 Opening of Bids

1.7.1 Bids will be opened immediately after closing time at the address given in the Sub Clause 1.6 of Section 1 and Bidders or their authorized agents will be permitted to be present at the time of opening of Bids, if they so desire.

1.8 Bid Security

- 1.8.1 Each Bid shall be accompanied by a Bid Security Guarantee, undertaking that the Bid will be held valid for the specified period, and that the Bid will not be withdrawn during that period. Such security shall be in the form of a Bank Draft or a Bank Guarantee issued by a recognized commercial Bank in Sri Lanka or a foreign bank with the guarantee confirmed by a recognized commercial bank operating in Sri Lanka, and approved by the Central Bank of Sri Lanka and payable to the CPC on demand in a sum of Sri Lankan Rupees Three Hundred Thousand only (Rs.300,000.00).
- 1.8.2 The Bid Security Guarantee shall be valid for 119 (Hundred and Nineteen) days (i.e. up to 09.07.2025) from the date of closing of the Bid. A format of Bid Security is attached in Annexure "B".
- 1.8.3 The Bid Security may be forfeited:
 - a) if the Bidder withdraws the Offer after Bid opening during the period of Bid validity; or
 - b) if the Bidder fails to accept the award within the stipulated time referred in Sub Clause 2.1.1; or
 - c) if the vessel offered is found not conforming to the agreed bid specifications upon inspection prior to delivery by the representative/s nominated by CEYPETCO, or if the delivered vessel does not conform to the agreed Bid specifications
 - d) if the Bidder does not accept the correction of the Bid price, pursuant to Clause 1.10 of Section 1; or
 - e) in the case of a successful Bidder, if the Bidder fails within the specified time limit to:
 - i. sign the contract; or
 - ii. Furnish the required Performance Security.
- 1.8.4 Bid Security from unsuccessful Bidders will be returned to them after the award is made to the successful Bidder. The Bid Security of the successful Bidder will be returned only after receipt of the Performance Guarantee.

1.9 Evaluation Criteria

- 1.9.1 Eligibility Criteria
 - 1.9.1.1 The service provider should be a company/consortium duly registered in Sri Lanka having excellent track records in the relevant field.
 - 1.9.1.2 All of the following documents must be submitted with the Bid for the bid to be eligible for evaluation;
 - i. Duly certified and singed "Form of Bid".
 - ii. Duly certified and signed "Offer Sheet".
 - iii. All documents and details to accompany the Bid as specified under sub clause 1.3 of the Section 1.
 - iv. Bid Security in the format specified in the Form A under Schedule C.
 - v. Documentary proof of authority for signing the Bid documents by the signatory of the Bid documents and documentary proof of authority required for any other requirements specified under this bidding document.
 - 1.9.1.3 All pages of the Bid document to be initialled by the authorized signatory to the Bid document.

- 1.9.1.4 The company or any member of the consortium should be free from any lawsuit(s) against the Company at present regarding the services offered by them.
- 1.9.1.5 The service provider shall be able to provide vessel(s) class with a member of IACS and possess valid ship's certificate and should have comprehensive valid insurance covers for the required services.
- 1.9.1.6 Bidder's previous experience in owning/operating tugs shall meet the minimum requirement of 3 years with reputed clients.
- 1.9.2 Technical Evaluation Criteria
 - i. All technical Parameters and minimum requirements specified in the Bidding document have to be met by the Bidder.
 - ii. Conformance to provide the vessel for a period of twelve (12) months when requested by CPC.
 - iii. Conformance to the Vessel Registration requirements of the Bidding document.

The offer complying with all of the above Eligibility and Technical Evaluation Criteria will be treated as substantially responsive bids for financial evaluation. However, any other criteria in addition to above may be added by the evaluation committee as deemed necessary at the evaluation stage of the Tender.

- 1.9.3 Financial Evaluation Criteria
 - i. The Bidder's annual turnover shall be at least LKR 600 Million during the last three financial years to establish the financial capability of the bidder.
 - ii. The financial evaluation will be based on the total cost of operation of the vessel comprising the following costs computed using the rates quoted by the bidder;
 - a) All inclusive rate per day/hrs. (including Fuel, water, lubricant manpower, consumable etc.) for the Hire.
 - b) Cost per meal (for CPC employees)
 - c) Cost of accommodation per person per day (for CPC employees)
 - Note: Based on the previous records, estimated usage per year for the above categories are as follows.
 - No. of days hired 09
 - No. of Meals 56
 - No. of Bunker Beds required 14
 - iii. The lowest quoted Bid out of the substantially responsive Bids will be selected as the successful Bid and the offered vessel will be inspected, prior to award of the contract subject to Clause 2.9.1.

1.10 Correction of Errors

- 1.10.1 Bids determined to be substantially responsive will be checked by the Employer for any arithmetic errors. Errors will be corrected by the Employer as follows:
 - a) Where there is a discrepancy between the amounts in figures and in words, the amount in words will govern; and
 - b) Where there is a discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern, unless there is an obviously gross misplacement of the decimal point in the unit rate, in which case the line item total as quoted will govern, and the unit rate will be corrected.

- c) If the total Bid price increases due to corrections made on above procedure, the bid price shall not be adjusted to the increased price and the corrections should be readjusted within the Bid price in consultation with the Bidder.
- d) If the bid price decreases by the above procedure, the amount stated in the Form of Bid shall be adjusted with the concurrence of the Bidder and shall be considered as binding upon the Bidder.
- e) If the bidder does not accept the corrected amount of bid, its bid shall be rejected and the bid security may be forfeited.

1.11 Right of the DPC to Accept or Reject any or all Bids

- 1.11.1 DPC will not be bound to make the award to the Bidder submitting the lowest offer.
- 1.11.2 The DPC reserves the rights to accept any Bid or to reject any or all Bids without adducing any reason.

2.1 **Performance Security**

- 2.1.1 The Bidder shall inform CEYPETCO of the acceptance of the award of the Bid within seven (07) working days from date of award.
- 2.1.2 Upon acceptance of the Bid, CEYPETCO reserves to itself the right to request a Performance Security (Unconditional) as per format annexed (please see 'Form B Format of Performance Security' of the 'Schedule C: Standard Forms') from the successful Bidder for a of Rs.1,500,000.00 be established within fifteen (15) working days from date of award of Bid.
- 2.1.3 The performance Security shall be issued in favour of CEYPETCO by a Licensed Commercial bank operating in Sri Lanka approved by the CBSL or a Bank based in another country but confirmed by a Bank operating in Sri Lanka approved by the CBSL to cover the performance by the successful Bidder of the terms and conditions of award of the Bid.
- 2.1.4 Such Performance Security shall be valid for a period of thirteen (13) months from the date of commencement of the contract on the supply of the vessel. Any extension to the contract shall be covered by a similar Performance Security in the same format. The successful Bidder shall forego any sum within the value of the performance security claimed by CEYPETCO to cover the losses in the event of non-fulfillment of the contract entered into or violation of any of the terms and conditions on the award of the Bid. Claim on the performance security shall be entertained by the Bidder's bank as aforesaid if they are received within a period of 30 days beyond the period of its validity (grace period of 30 days).

2.2 Mode of Payment

- 2.2.1 Successful Bidder shall submit invoices with relevant proof documents for the services provided to CEYPETCO at the end of each service. Payments will be made within thirty (30) days after acceptance of the invoice by CEYPETCO.
- 2.2.2 All taxes, harbor dues & port charges pertaining to the vessel shall be payable by the vessel owner.
- 2.2.3 All payments will be made to the successful Bidder in Sri Lankan Rupees.
- 2.2.4 Payments will be paid based on actual usage after certified by Manager (Operations, Offshore CPSTL) or his authorized officer.

2.3 Period of hire of the Vessel

- 2.3.1 The selected supplier shall supply a vessel when and where required within a one year period with effect from 01st of May 2025.
- 2.3.2 CEYPETCO reserves the right to extend this Contract for a further period of six months based on requirements at CEYPETCO on the same terms and conditions subject to approval of the relevant Procurement Committee. This contract with a notification to the Supplier thirty days in advance.

2.4 **Requirements for the Vessel**

- 2.4.1 The vessel shall have appropriate class notation to carry out the work specified in the bidding document. All certificates listed in item 10A of 'Schedule B: Format of Offer' shall be available on board the vessel and these certificates shall be authenticated by a member of society of International Association of Classification Societies (IACS). Certified copies of such documents shall be submitted with the Bid.
- 2.4.2 The vessel shall be capable of performing the following duties:

- a) Transferring personnel and equipment between shore and tanker/SPBM.
- b) Handling floating hoses and transferring them to and from tanker and shore.
- c) Maintenance of Pipe Line End Manifold (PLEM), submarine pipeline, buoy and hoses.
- d) Should be able to go near and alongside the tanker together with the hose.
- e) Provision of and storage for anti-pollution equipment and chemicals.
- f) Keeping a tanker of max., 180,000 DWT off buoy by pulling or pushing from both bow and stern of the tanker.
- g) Maintain the stability and the position while towing the tanker until the completion of discharge.
- h) Towing arrangements to be available at both bow and stern of the tug with the use of stern rope provided by the tanker.
- i) Inspection, installation, repair & maintenance, removing, towing, loading and unloading from the MERV of both floating and under buoy hoses.
- j) 230V single phase power should be provided in the deck for diving bottle charger on deck.
- k) Communication should be available through VHF with CPC control room and phone should be available in the vessel.
- 2.4.3 The vessel shall have tug like maneuvering capabilities for tanker mooring operations and have rounded hull with robust fendering for alongside work with tankers. The bow configuration should be rounded. In the case of pointed bow the Bidder shall provide adequate protection by a fendering arrangement, which shall not hinder any of the operational requirements of the tug. This fendering arrangement shall be to the satisfaction of CEYPETCO so that the tug could be used for pushing other vessels.
- 2.4.4 The vessel shall be available to perform any other duties inclusive of carriage of cargo within its limits of capability in Sri Lanka Exclusive Economic Zone (EEZ) and work pertaining to any other SPBM.
- 2.4.5 The vessel offered shall conform to the specifications stipulated in 'Section 3:

Specifications of the Vessel' and 'Schedule B: Format of Offer' at the time of delivery on the date required by CEYPETCO. Individual Bids shall be submitted on separate offer sheets obtained from CEYPETCO with separate Bid Bonds if the Bidder is offering more than one bid. Please attach the copy of the receipt of payment pertaining to obtaining each such document to the offer sheet.

- 2.4.6 In the Bids for the Contract, the Bidder shall be the owner or have purchase agreement with the owner or Time Charterer by demise or Manager of the Vessel offered. All necessary documentary proofs required to be submitted along with the bid. The Contract Agreement shall be signed only with the owner or Demise Charterer or Manager of the vessel.
- 2.4.7 The vessel crew should handle the following jobs
 - Pick up the CPC/CPSTL crew from harbor to the tanker/ SPBM and return them to the harbor after operations.
 - The intended operations should be carried during day/night of the day.
 - Pick up hawser and hose and hand over them to the tanker.
 - Handle the stern rope provided by the tanker and manage the towing arrangements
 - Provide assistance in transferring CPC/CPSTL crew and equipment to the tanker/ SPBM.
 - Operation of run-about /boat.
 - Assistance for CPC/CPSTL crew to attend any repair on the SPBM system while in operation.
- 2.4.8 Replacement tug should be provided within a reasonable period not to interrupt the operation and Payment will only be made/done after proper completion of operations.

2.5 Rate for hiring of a Vessel

2.5.1 The offer shall indicate clearly the Rate per days/hrs. in Sri Lankan Rupees. The Rate quoted should be valid for a period of 12 months from the date of commencement of the Contract. Rates for providing meals and accommodation per-head basis, to personnel other than the crew members, as required by CPC should be stated separately for the aforesaid period of hire of the vessel. (Please see Item No. 7 (F) and Item No. 15 of the 'Schedule B: Format of Offer')

2.6 Supply of Fuel and other consumable

2.6.1 The fuel and other consumables required for operational activities of the vessel should be supplied by the vessel supplier/Bidder and the cost for those items should be included in the rate quoted by the bidder.

2.7 Other Conditions

- 2.7.1 CEYPETCO reserves to itself the right to communicate with any party mentioned in the offer for reference/clarifications.
- 2.7.2 Bidder shall at the time of Bidding provide all valid certificates required by the Bidding Document as specified in item 10A of the 'Schedule B: Format of Offer', in respect of the vessel offered and ensure that certificates are valid throughout the period of contract (certification of validity to be as per Sub Clause 1.3.1.5 of the Section 1).
- 2.7.3 Bidder shall notify CEYPETCO, 10 days in advance if the tug is to be engaged with other parties or transferred out of Colombo Port area during the Contract period.
- 2.7.4 Bidder shall clearly indicate if any specific conditions applicable for payment of hiring of tug (Minimum Payment, pro-rata basis, etc.) in Item No. 15.3 of Schedule B: Format of Offer.
- 2.7.5 CPC may have sole discretion to terminate the contract with a four (04) months' notice, if the supplier's service is not satisfactory.

2.8 The Governing Law

- 2.8.1 The Bidder shall comply with and conform to all laws of Sri Lanka in executing its operation. Arbitration if any, arising from CPC shall be governed by Sri Lanka Laws and the venue of arbitration shall be Colombo, Sri Lanka.
- 2.8.2 All provisions of this Bidding Document and contract to be signed shall be subject to standard Force Majeure conditions.

2.9 Inspection of the Vessel

2.9.1 Offered vessel will be inspected by an inspection team comprising an Engineer/Mooring Master from CPSTL & a representative from CEYPETCO, prior to award of the contract.

SECTION 3 – SPECIFICATIONS OF THE VESSEL

The vessel shall comply with the following requirements

3.1 Dimensions

- a) Length overall should be a minimum of thirty five meters (35m) and not more than sixty meters (60m).
- b) Breadth moulded should be not less than ten meters (10m).
- c) Depth moulded should be not less than four meters (4m).
- d) The vessel shall have a rounded hull. All conditions of the sub clause 2.4.3 of section 2 should be met.

3.2 Propulsion

3.2.1 Twin screw propulsion system - with main engines developing a total BHP of minimum 3000 (Three Thousand) continuous rating.

3.3 Bollard Pull

- 3.3.1 The vessel's continuous static bollard pull shall be not less than 40 MT.
- 3.3.2 The Bidder shall submit a copy of vessel's certified Continuous Static Bollard Pull Certificates issued within twelve months prior to closing date of the Bid. This document shall be certified by one of the classification societies listed in item 9 A of 'Schedule B: Format of Offer', or by a competent authority acceptable to CEYPETCO.

3.4 Bow Thruster

3.4.1 Bow thruster developing 3-7 MT of thrust at continuous rating and not less than three hundred (300) BHP should be provided. Bow thruster to be operated independent of all other machinery.

3.5 Speed:

Service speed of minimum ten (10) knots

3.6 Deck Requirements

- a) Front Deck Arrangements
 - i. Tugger winch arrangements to pickup the hose with the use of hose pickup rope to handover it to the tanker.
- b) Deck crane must be,
