01. Product should have made using high quality natural leather.
02. The country of manufacturing should be Sri Lanka, USA, Europe, Japan or Australia. A certificate conforming the country of manufacturing issued by the relevant government authority should be attached with the offer.
03. Product must carry the CE mark and technical data should be given with the offer.
04. Category of protection offered should be CE EN 345-1 or CE EN 347-1 conforming to latest editions. (Manufacture should prove that the product meets the above standards).
05. Date of manufacture to be embossed on out sole.
06. UK / FRENCH sizing embossed on out sole.
07. Toe protection tested with 200 Jules impact. (Conforming to latest edition of EN 347)
08. Heat resistant on cleaned out sole - specify the temperature.
09. Penetration Resistant outsole (Mid plate construction).
10. Anti - Static property (to be embossed on out sole) or to be given in the manufacture's technical data.
11. Slip resistant property (to be embossed on out sole) or to be given in the manufacture's technical data.
12. Water resistant upper leather and out sole.
13. Cut resistant.
14. Ankle type toe protection.
15. Product to be ergonomically designed to have superior fit, comfort and compatibility for longer period of wearing capability by reducing the foot fatigue.
