Instructions to bidders & Conditions of the tender:

1. *Sealed Bids are invited for the Sale of Unserviceable Used Items as mentioned in the Bid form attached hereto.*
2. *Intending Bidders should pay a refundable deposit of Rs. 10,000.00 and a non-refundable document fee of Rs. 1,000.00 in cash to the Senior Manager (Finance), Refinery on or before 16-February-2026. Above deposit will be treated as the Bid Bond. (Copy of the receipt/s of payment shall be attached to the bid)*
3. *Deposits of the unsuccessful Bidders will be released only after the tender was awarded to the successful Bidder & the successful bidder's deposit will be released after receipt of the Performance Guarantee.*
4. *Bids for the sale should be made only in the sub-joined bid form.*

Where there is a discrepancy between the amount in figures and in words, the amount in words will govern.

5. *Bids should be sent under sealed cover by registered post or may be deposited in the Tender Box provided for this purpose at the Refinery Manager's Office, Refinery Division, Sapugaskanda, Kelaniya. The top left hand corner of the envelope containing the Tender should be clearly marked as follows.*

6. *Bids close at 1430 hours on 18-February-2026 & will be opened immediately thereafter at the Refinery Conference Room.*
7. *All Bids will be deemed to be valid for a period of 63 days from the date of closing of this Tender.*
8. *It will be the responsibility of the prospective Bidders to examine the items by arrangement with the officer authorized by the Manager (Materials) before he makes his offer. The Ceylon Petroleum Corporation does not guarantee the quality and quantity of the materials therein. (Kindly be informed that actual quantity available could be less or greater than indicated in the document).*
9. *Failure on the part of the successful Bidder to accept the award of this Tender and or fail to comply with other contractual terms specified herein, will result in the award being withdrawn, the forfeiture of the Refundable Deposit / Performance Guarantee and black-listing of such defaulters.*

10. *The notice of acceptance of this Tender will be deemed to have served as received by the successful Bidder if it has been sent per registered mail addressed to or left at the address given by the bidder in the sub-joined bid form.*

11. *Successful bidder shall make additional 10% of the awarded value as a Performance Security Guarantee which will be refunded on successful completion of the contract.*

12. *The successful Bidder and his workers should strictly adhere to Refinery Safety Procedures and Administrative Procedures.*

Also, the followings are the responsibilities of the bidder/contractor

A. *An insurance cover for equipment to remove used steel items; so that CPC will be released from any responsibility regarding accidents, losses etc...*

B. *An insurance cover for all manpower at site as per the Workmen Compensation Act.*

13. *The Department Procurement Committee reserves the right to accept a Tender in whole or in part, or to reject any or all the tenders & remove any item after awarding of the tender without assigning any reason.*

14. *All payments should be made in cash to the Senior Manager (Finance), Refinery, within 14 days from the date of letter awarding the tender.*

15. *The collection of Unserviceable Items should be done systematically from one end to the other and random collection is not permitted.*

Removal should be done to the ground level free of all rusted steel pieces & sludge if applicable.

All necessary lifting equipment such as Fork Lifts required should be brought by the bidder.

The bidder should clean the site to the satisfaction of the CPC. All debris & non Steel Material such as plastic, wood and asbestos etc. to be collected in to a single pile when cleaning the site by the contractor. This lot shall not be removed by the contractor.

If the actual quantities of steel items in the lots exceed the quantity mentioned in the Bid-Form, CPC reserves the right to limit the quantity sold by the tender to the specified quantity & terminate the contract at sole discretion of CPC.

16. *Removal of Unserviceable Used Electrical Items should be completed within 14 working days (2 calendar weeks) from the date of the letter awarding the Tender. CPC reserves the right to forfeit the Performance Guarantee at sole discretion of CPC in case of failure in completing the removal of Unserviceable Used Steel Electrical Items in 14 working days. This deadline will not be extended for any reason.*

17. *Refinery is situated in a high security zone. Hence, it is the responsibility of the bidder/contractor to check with the Manager (Materials) of necessary prior arrangements and security requirements to be fulfilled when removing Items from Refinery.*

18. *Bidder should have valid licenses, permission (if applicable) to buy from relevant government authorities such as Central Environmental Authority defending on some items such as waste lube oil & it is the responsibility of the bidder to ascertain such requirement before submitting a bid. After awarding of tender, CPC will not allow successful bidder to sublet the award to other party.*
19. *Any further clarification with regard to the Tender should be sought from the under mentioned only up to the closing date of issuing of Bidding documents.*
