Bidders who download the documents must deposit the required fee into Account No. 004100110208633, Ceylon Petroleum Corporation, People’s Bank (Head Office), and submit the payment receipt together with the Bid.*

*The bid will be closed at **1400 hrs on 18.08.2026** and opened at the office of Manager (Procurement & Stores), at the above address, immediately after closing time of the Bid. Bidders or their authorized representative will be permitted to be present at the opening of Bid. As per the Public Contract Act No. 3 of 1987, the Prospective Bidders shall be registered in Department of Registrar of Companies through <https://eroc.drc.gov.lk/> website and submit PCA 3 certificate along with their Proposal.*

1. INSTRUCTIONS TO BIDDERS

1.1 Introduction

Ceylon Petroleum Corporation (CPC) is calling Bids from contractors who have past experiences in similar work for the contract “Fabrication, Transport & Installation of Hording Boards in CPC Outlets Islandwide”.

Eligibility Criteria

- Bidder shall not have been blacklisted
- Bidder shall have successfully completed previous contracts of similar nature at least having contract values of Rs. 20.0 million for past 03 years (2025,2024,2023)

1.2 Content of the Bidding Documents

Bidding Document will consist of the followings ;

- 1.2.1 Instructions to Bidders (ITB)
- 1.2.2 Conditions of Contract (COC)
- 1.2.3 Technical Specifications
- 1.2.4 Bill of Quantities
- 1.2.5 Form of Bid
- 1.2.6 Format of Bid Security Guarantee
- 1.2.7 Form of Agreement
- 1.2.8 Format of Performance Guarantee

1.3 Documents to accompany the Bid

All Bidders shall furnish adequate information in respect of the items offered.

Failure to furnish the following documents and details, with the bid may result in the Bid being rejected. All documents shall be furnished in English language.

- 1.3.1 Supplier should provide manufactures specifications together with a guarantee for a period of 10 years .
- 1.3.2 Past performance - Bidder should furnish previous experience on this type of job with necessary details for the consideration in evaluation with the tender. A list of construction during last 12 months also to be submitted.
- 1.3.3 Schedule of Prices duly completed and signed.
- 1.3.4 Form of Bid (Annex A) duly completed and signed.
- 1.3.5 Bid Security
- 1.3.6 Manufacture authorization letter/business registration

1.4 Sealing and marking of Bids

Bids shall be submitted in duplicates. The original and the duplicate of the Bid shall be placed in separate envelopes marked 'ORIGINAL' and 'DUPLICATE' and shall be marked "**BID FOR THE Fabrication, Transport & Installation of Hording Boards in CPC Outlets Islandwide**" on the top left hand corner and the statement, "**DO NOT OPEN BEFORE 1400 hrs on 18.08.2026**" (to be completed with the time and date specified in the Bidding Document and shall be addressed to;

If the envelope is not sealed and marked as stated above, CPC will not take the responsibility for the Bids being misplaced or premature opening. In the event of any discrepancy between the Original and the Duplicate, the Original shall govern.

1.5 Period of validity of Bids

All bids shall be valid for a **minimum period of Ninety One (91) days (i.e. upto 16.11.2026)** from the closing date of the Bid. **A Bid valid for a shorter period will be rejected as non-responsive.**

1.6 Signing of Bids

The Original and the Duplicate of the Bid shall be typed, or written in indelible ink, and shall be signed by the Bidder. **All pages of the Bid except for un-amended printed literature shall be initialed by the person(s) signing the Bid.**

Any inter lineation, erasures or over-writing shall be valid only if they are initialled by the person(s) signing the Bid.

1.7 Clarification of Bidding Document

A prospective Bidder requiring any clarification of the Bidding Document should notify CPC in writing by hand or post or facsimile at the CPC's mailing address indicated in the Bidding Document clause 1.4. Similarly if a Bidder feels that any important provision is unacceptable, such objection should be raised at this stage. CPC will respond in writing to any request for clarification or modification of the Bidding Document that is received not later than Seven (07) days prior to the deadline of submission of Bids prescribed by the CPC.

1.8 Deadline for submission of Bids

CPC must receive Bids at the address specified in ITB Clause 1.4, not later than **1400 hrs. on 18.08.2026.**

1.9 Late Bids

Any Bid received by CPC after the deadline for submission of Bids, will be rejected and returned unopened to the Bidder.

1.10 Withdrawal of Bids

A Bidder wishing to withdraw his Bid shall notify the CPC in writing prior to the deadline prescribed for the submission of Bids. A withdrawal notice may also be sent by Facsimile, but must be followed by the original, by post or by hand not later than the deadline for submission of Bids. The notice of withdrawal shall be sent to the Manager (Procurement & Stores), which the address is given in Clause No.1.4.

1.11 Closing of Bids

Bids shall be closed at **1400 hrs on 18.08.2026** and hence bids shall be reached to the address given in clause no. 1.4 before the time and date specified in clause no. 1.8.

1.12 Opening of Bids by CPC

Bids will be opened immediately after the closing date and time fixed for receipt of Bids. The address where bids are opened is given in clause 1.4.

1.13 Agent's Authority :

An Accredited Agent of the manufacture signing the Bidding Document on behalf of the Principal shall state the Principal's name and address, telephone number and fax number, (if any) and a letter of Authority empowering the agent.

Nomination of an Agent after the Bid has been submitted will not be valid.

1.14 Bid Security Guarantee

Each Bid shall be accompanied by a Bid Security Guarantee, (if requested) undertaking that the bid will be held valid for the specified period, and that the bid will not be withdrawn during that period. Such security shall be in the form of a Bank Draft or a Bank Guarantee issued / confirmed by a recognized Bank in Sri Lanka, and payable to the CPC on demand in a sum of **Rs. 275,000.00**. The Bid Security Guarantee should be valid for Hundred & Nineteen (119) days (**i.e. up to 14.12.2026**) from the date of closing of Bid. A form of Bid Security Guarantee is attached in Annex "B".

Failure to submit the Bid Security Guarantee at the time, or before the closing of Bid, and in accordance with above said requirements, and in the format provided, will result in the Bid being rejected. Bid Security Guarantee from unsuccessful Bidders will be returned to them after the award is made to the successful Bidder. The Bid Security of the successful Bidder will be returned only after receipt of the **Performance Security Guarantee**.

1.15 Schedule of Prices

Bidders are required to duly sign and return the "Schedule of Prices" as indicated in the bidding document.

1.16 Preliminary Examination of Bids

CPC will examine the Bids to determine whether they are complete, any computational errors have been made, whether the documents have been properly signed, and the Bids are generally in order. If not, CPC may at its discretion call clarifications from the Bidder. The request for clarification and the response shall be in writing within one week's form the clarifications and no change in the price or substance of the Bid shall be sought, offered or permitted.

1.17. Correction of Errors

Bids determined to be substantially responsive will be checked by the CPC for any arithmetic error. Errors will be corrected by the CPC in the following manner;

- 1.17.1 Where there is a discrepancy between the amounts in figures and in words, the amount in words will govern; and
- 1.17.2 Where there is a discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern, unless there is an obviously gross misplacement of the decimal point in the unit rate, in which case the line item total as quoted will govern, and the unit rate will be corrected.
- 1.17.3 If the total bid price increases due to corrections made on above procedure, the bid price shall not be adjusted to the increased price and the corrections should be readjusted within the bid price in consultation with the bidder.
- 1.17.4 If the bid price decreases by the above procedure, the amount stated in the Form of Bid shall be adjusted with the concurrence of the bidder and shall be considered as binding upon the bidder.
- 1.17.5 If the bidder does not accept the corrected amount of bid, its bid shall be rejected and the bid security may be forfeited.

1.18 Evaluation of Bids:

CPC will carry out a detailed evaluation of Bids, to determine whether the Technical aspects are properly addressed, and the Bids are substantially responsive.

1.19 CPC's right to accept or reject any or all Bids

The CPC will not be bound to make the award to the Bidder submitting the lowest offer.

The CPC reserves the right to reject any or all Bids or any part thereof, without assigning any reasons. The CPC may accept any or all items of an bid, and reserves the right to increase or decrease the number of units to be contracted for, at prices indicated in the Schedule of Prices.

1.20 Notice of Acceptance

The notice of acceptance of Bid will be sent by facsimile, followed by post to the successful Bidder, to the address given by him in the Bidding Document, soon after the decision of the CPC.

1.21 Award Criteria

1.21.1 Subject to ITB Clause 1.18, the CPC will award the contract to the successful Bidder, whose Bid has been determined to be substantially responsive, lowest evaluated Bid, provided that the Bidder is determined to be qualified to perform the contract satisfactorily.

1.21.2 The successful Bidder will be called upon to supply or part there off conforming to Technical Specifications, and strictly by the agreed date of completion.

1.21.3 If the Successful bidder is called upon to enter in to an Agreement with CPC, the bidder should be ready to sign an agreement with CPC.

2. CONDITIONS OF CONTRACT (COC)

2.1 Performance Security:

If it is applicable, the successful Bidder will be notified by CPC to furnish a Performance Guarantee. This guarantee shall be submitted on his owned cost and within fourteen (14) days of such notification through / confirmed by a reputed Commercial Bank in operation in Sri Lanka, for a sum equivalent to 10% of the total Bid value of the accepted Bid. The Performance Security shall be complied to the format given in Annex C. The period of validity of this performance security shall be the expected period of delivery of goods/equipment plus one month. (i.e. period of the contract plus one month)

If the successful Bidder fails to furnish the Performance Security aforesaid, his name will be placed in the list of defaulting Contractors. CPC shall therefore, be entitled in its absolute discretion to make suitable arrangements required for the performance of such Bid, as the case may be, at the risk and expense of the successful Bidder.

The successful Bidder, in the event of his failure to furnish the Performance Security as required, shall be liable for any losses, costs expenses and damages, which the CPC may sustain in consequence of such failure, and the Bid security shall be forfeited.

2.2 Mode of Payment

Payments will be done within a period of thirty (30) days from the date of submission of invoice after the successful installing and handing over.

2.3 Completion of the Contract

Period of completion shall be **three (03) months** from the date of confirmation of the order.

2.4 Defaults by Successful Bidder

If the successful Bidder, defaults in the supply or otherwise commit a breach of any of the provisions in the Contract with CPC, he shall be liable to pay to CPC, all losses, damages and expenses incurred by CPC, in consequence of such default or breach. Bidders should declare that they had read the Bid conditions, and that they make the offer in compliance with, and subject to all the conditions thereof, and agree to perform the services in accordance with the said conditions in the manner therein set out, and in terms of this offer. A Form of Bid, as Annex- 'A' is attached.

2.5 Liquidated Damages

Liquidated Damages amounts to Rs. 1/2000 of the contract value will be levied per each day delayed beyond the period of delivery specified in the contract up to the maximum of 10%.

2.6 Force Majeure:

Except as regards an act of God, War, Strike, Invasion, Civil war, Rebellion Revolution, Insurrection, Earthquake or Plagues, the Bidder shall undertake all risks and liabilities of whatsoever kind arising out of incidentals connected with the sale.

2.7 Arbitration.

If during the continuance of this Contract or at any time after the termination thereof, any disputes or differences of opinion touching the interpretation of this contract were to arise between the parties hereto or their respective representatives, such differences or disputes shall be referred for Arbitration.

Arbitration shall be conducted under the rules of ICLP (Institute of the Development of Commercial Law & Practice), Arbitration Centre and in accordance with the arbitration Act No. 11 of 1995 of Sri Lanka. The place of Arbitration shall be Colombo, Sri Lanka.

2.8 Termination

CPC may at any time terminate the contract by giving written notice to the contractor, if the Contractor breach of any of the provisions in the contract with CPC for the providing of the said professional service or becomes bankrupt or otherwise insolvent. In this event, termination will be done without compensation to the Contractor, provided that such termination will not prejudice or effect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

2.9 Particular Conditions of Contract

- 2.9.1 This work includes Shop drawings to should be done by the contractor to the art work provided by CPC and the approval should be obtained from the CPC prior to fabrication.
- 2.9.2 The rate shall include for transport, scaffolding etc for each location required for the work In addition to this BOQ.
- 2.9.3 The sample will be checked by the CPC officers/Engineer and the required amendments to be done accordingly (free of charge) by the contractor.

2.9.4 Supply , fabrication , Transport and install of hoarding board of size 3000mmx6000mm using steel hollow box sections 25mmx25mmx2.3mm around to frame with two horizontal supports fix at equal interval and vertical supports of hollow box sections 25mmx25mmx2.3mm of every 1.0m centres and fix to 02 Nos 126mmx76mm 13(kg/m)universal columns as per detail drawing . 3. TECHNICAL SPECIFICATIONS

FLEX SURFACE PRINTING

(Outdoor Hoardings – Island-wide Deployment)

1. Scope

Supply, digital printing, finishing, and installation of outdoor-grade flex surfaces for steel hoardings installed island-wide in Sri Lanka.

2. Hoarding Sizes Covered

- 20 feet × 10 feet
- 30 feet × 10 feet

3. Flex Material Requirements

- Type: Premium Front-lit PVC Flex
- Minimum Thickness: **440 GSM**
- Preferred Thickness: **510 GSM**
- Base Fabric: High-tensile polyester
- Finish: Smooth, uniform white
- Tear Resistance: Suitable for high wind load

4. Printing Requirements

- Printing Technology: Eco-solvent / Latex / UV
- Resolution: Minimum 720 DPI (Preferred 1440 DPI)
- Ink Type: Outdoor UV-resistant ink
- Colour Output: Uniform, non-patchy, no banding

5. Colour & Weather Durability

- UV resistance: Minimum 24–36 months
- Resistant to rain, humidity, heat, and dust
- Shrinkage: Less than 1%
- Optional UV lamination recommended for highways and coastal areas

6. Paneling & Jointing

- Single-piece flex preferred
- If jointed: heat-welded seams only
- Overlap pasting strictly prohibited
- Seam strength must match base material

7. Eyelets & Edge Reinforcement

- Edge reinforcement: Heat-sealed
- Eyelets: Aluminum or brass (rust-proof)
- Spacing: Every 300 mm (12 inches)
- Reinforced edge margin: 40–50 mm

8. Fixing Method

- Nylon rope or PVC-coated GI wire
- Uniform tension without sagging
- Flex must be removable and replaceable

9. General Structural Enhancements

9.1. Steel Structure

- All steel members to be **hot-dip galvanized** (minimum 80 microns)
- Welding to be continuous and treated with zinc-rich primer
- Epoxy or PU top coating recommended for coastal areas

9.2. Wind Load Protection

- Rear diagonal cross bracing mandatory
- Rounded frame corners to reduce stress concentration
- Rubber padding between frame and flex
- Optional rear GI backing sheet in wind-heavy locations

9.3. Foundation & Footings

- Concrete grade: Mentioned
- Minimum footing depth: Mentioned (soil dependent)
- Galvanized anchor bolts preferred
- Drainage / weep holes at base to prevent water accumulation

10. Recommended Installation Zones

- Urban areas
- Town centers
- Medium wind exposure locations
- Highways
- Coastal belts
- Open and high-wind regions

11. Flex Protection & Longevity Enhancements

- UV protective lamination for colour life extension
- Rubber gaskets at frame contact points
- Rounded frame edges to prevent tearing
- Bottom gap for water drainage
- Standardized eyelet grid across all hoardings

12. Maintenance & Replacement Guidelines

- Flex must be replaceable without cutting the frame

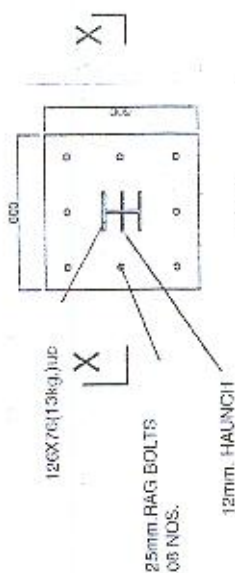

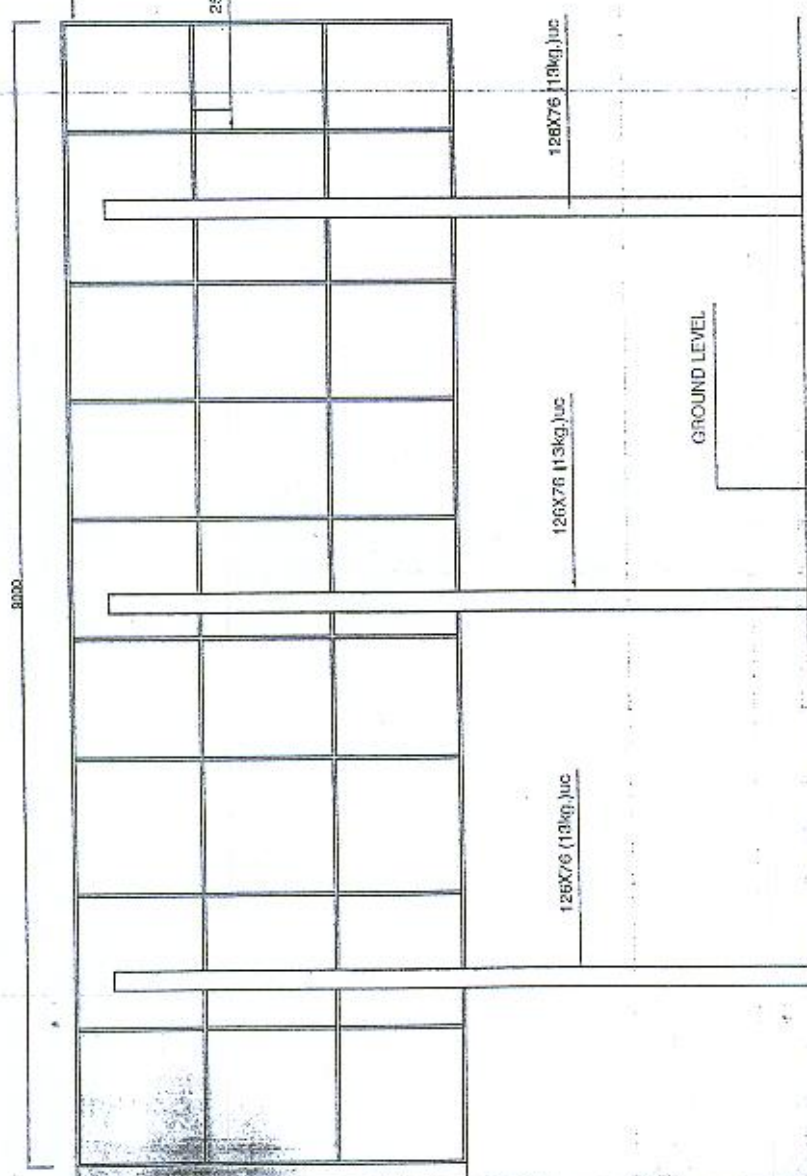
