1. The Chairman, High Level Procurement Committee, on behalf of the CEYLON PETROLEUM CORPORATION invites sealed bids from eligible and qualified foreign and local ship owners, demise Charterers, shipbrokers, ship managers, local and foreign ship agents & representative, for the Time Chartering of a vessel, based on the following Eligibility Criteria, for Maintenance and Emergency Response work connected with SPBM facility, for the period of Twenty-four (24) months commencing 1000 hrs. on 01.12.2026.
2. Bidding will be conducted through International Competitive Bidding Procedure.
3. To be eligible for contract award, the prospective bidder shall not be blacklisted and shall meet the following requirement;
 - i. The bidder shall be a company/consortium duly registered in Sri Lanka or in any other country having excellent track records in the relevant field.
 - ii. The bidder shall have a valid certificate "FORM PCA 03" issued by Registrar of Public Contract in terms of the Public Contract Act No. 3 of 1987 at the time of bid opening.
 - iii. The company or any member of the consortium shall be free from any lawsuit(s) against the Company at present regarding the services offered by them.
 - iv. The bidder shall be able to provide vessel(s) class with a member of IACS and possess valid ship's certificate(s) and shall have comprehensive valid insurance covers for the required services.
 - v. Bidder's previous experience in owning/operating tugs shall meet the minimum requirement of 3 years with reputed clients.
4. To be eligible for awarding the Contract, the successful Bidder shall not have been blacklisted and shall have complied with the eligibility and qualification criteria stated in the Bidding Document.
5. Bidding Documents may be obtained on working days between 0900 hrs. and 1500 hrs. up to 19.10.2026 from the office of the Manager (Procurement & Stores), Ceylon Petroleum Corporation, 1st Floor, No. 609, Dr. Danister De Silva Mawatha, Colombo 09, upon submission of a written request.
6. Local bidders shall deposit the prescribed non-refundable bidding document fee of Rs. 200,000.00 (Rs.165,357.59 inclusive of 2.5% SSCL and 18% VAT) to the CPC bank account specified below and obtain the Bidding Documents upon submission of the original payment receipt.
7. Foreign bidders may download the Bidding Documents from the CPC website and shall remit a non-refundable fee of US\$ 670 to the USD account specified below. A copy of the remittance

SECTION 1 – INSTRUCTION TO BIDDERS (ITB)

1.1 Introduction

- 1.1.1 The Chairman, High Level Procurement Committee (HLPC) on behalf of the Ceylon Petroleum Corporation (hereinafter referred to as CEYPETCO) invites sealed bids from eligible and qualified bidders for the Time Charter of a vessel for Maintenance and Emergency Response Work connected with the Single Point Buoy Mooring (SPBM) installed off-shore Colombo Harbour for Twenty-four (24) months period commencing from 1000 hrs on 01.12.2026.
- 1.1.2 The intended Service Period is Twenty-four (24) months with the option to extend further by maximum of Twelve (12) months in full or in part/parts as determine by CEYPETCO with the approval of the Government of Sri Lanka.
- 1.1.3 The bidding will be conducted through International Competitive Bidding (ICB) Procedure.
- 1.1.4 Interested eligible bidders may obtain further information from Manager Procurements & Stores Function of Ceylon Petroleum Corporation [Email: procuregeneral@ceypetco.gov.lk] and inspect the Bidding Documents at the address given below from 0900 hrs. to 1500 hrs. on working days up to 19.10.2026.

1.2 Issue of Bidding Document

- 1.2.1 Bidding Documents may be obtained on working days between 0900 hrs. and 1500 hrs. up to 19.10.2026 from the office of the Manager (Procurement & Stores), Ceylon Petroleum Corporation, 1st Floor, No. 609, Dr. Danister De Silva Mawatha, Colombo 09, upon submission of a written request.
- 1.2.2 Local bidders shall deposit the prescribed non-refundable bidding document fee of Rs. 200,000.00 (Rs. 165,357.59 inclusive of 2.5% SSCL and 18% VAT) to the CPC bank

account specified below and obtain the Bidding Documents upon submission of the original payment receipt.

- 1.2.3 Foreign bidders may download the Bidding Documents from the CPC website and shall remit a non-refundable fee of US\$ 670 to the USD account specified below. - 1.2.4 Bidders shall submit a copy of the payment receipt together with their Bid. Bidders who download the bidding documents from the CPC website are also required to notify their intention to participate in the bid by email to procuregeneral@ceypetco.gov.lk immediately after downloading the documents.

1.3 Documents and Details to Accompany the Bid

- 1.3.1 All Bids shall contain adequate particulars as required under the Bidding Document. Failure to furnish the following documents and details before the closing of Bids may result in the Bid being rejected. All documents shall be furnished in English Language.

1.3.1.1 Bids duly completed according to the format of the Offer Sheet in the Schedule B (Format of Offer) shall be submitted together with the duly completed and certified declaration form in Schedule A: Form of Bid.

1.3.1.2 Detailed Bid with time charter rate in US Dollars per day for the period of the contract (Please see Section 2- Sub Clause 2.5), the consumption of fuel at modes of operation as specified in Section 2 - Sub Clause 2.6 and the date of availability of vessel at Colombo shall be submitted by the Bidder.

1.3.1.3 Bidder shall indicate in the Bid: -

- a) Ownership of the vessel with documentary proof including purchase agreement if any.
- b) Whether Bidder is a Charterer by demise of the vessel (with signed copies of relevant Charter Parties).
- c) Whether Bidder is the Manager of the vessel with documentary proof.

- 1.3.1.4 Specifications of the vessel offered, together with all certificates to establish that the vessel offered conforms to the specifications stipulated in 'Section 3: Specifications of the Vessel'. All questions of the offer sheet must be answered without any amendments or deletions to the items or CEYPETCO requirements/ specifications mentioned therein and submitted with the Bid.
- 1.3.1.5 Valid certificate "FORM PCA 03" issued by Registrar of Public Contract in terms of the Public Contract Act No. 3 of 1987
- 1.3.1.6 Valid certified copies of all certificates required as per item 10A of 'Schedule B: Format of Offer' and general arrangement drawings of the vessel shall be submitted along with the Bid. Certification of validity to be by representative of classification society who shall have full-time membership of International Association of Classification Societies (IACS) in which vessel is registered as referred to in item 9A of 'Schedule B: Format of Offer'.
- 1.3.1.7 The Copies of the Memorandum and Articles of Association of the Company certified by the Registrar of Companies or a valid partnership agreement as the case may be of the party who is the ship owner /demise charterer of the vessel offered and the signatory to the charter party.
- If the bidder is participating in the capacity of a representative, agent, ship broker, ship manager of a foreign ship owner/demise charterer shall provide valid proof document to establish his authority to act on behalf of the principal. The proof of documents such as Board Resolution of the company or the consent of all the partners in the partnership as the case may be in each of these cases shall be submitted along with the bidding documents. The Charter Party shall be signed only with the owner or Demise Charterer or Manager of the vessel.
- 1.3.1.8 The Bidder shall submit a Board Resolution of the company or the consent of all the partners in the partnership as the case may be authorizing the signatory to sign;
- (a) the bid documents and
- (b) the charter party in case their bid is accepted by the CEYPETCO. (The Charter Party shall be signed only with the owner or Demise Charterer or Manager of the vessel).
- 1.3.1.9 The audited final accounts for the three financial years commencing from 01st of January 2023 to 31st December 2025 or 01st of April 2023 to 31st March 2026 (Whichever applicable) including those of the Principal (if the Bidder is not the Owner) and name of three (03) banks or other financial establishments and the company lawyers if available, from whom reference could be obtained shall be submitted by the bidder described sub clause 1.3.1.6 above.

1.3.1.10 The Bidder shall have not less than three years of experience in owning/operating tugs. All necessary documentary proofs required to be submitted along with the bid including the contact details of the Clients.

1.3.2 Required Information and Documents Pertaining to Local Agents

In the case where a Bidder uses a local agent(s) the Bidder shall furnish all the following information/documents pertaining to their local agent(s), with their Bid/proposal.

- a) The name and address of the local agent(s).
 - b) The year of registration of the business of the local agent(s).
 - c) The registration certificate according to Public Contract Act of No. 3 of 1987, (a certified copy).
 - d) A certified copy of the audited accounts of the local agent(s) for any one of the two financial years immediately preceding the date of submission of Bids or proposals, audited by an independent external auditor in accordance with the Sri Lanka Auditing Standards together with the auditor's report confirming that the accounts were prepared in accordance with the Sri Lanka Accounting Standards.
- and
- e) All details of commissions or gratuities, if any, paid or to be paid by the Bidder to the local agent(s) connected with or relating to the Bid or proposal up to contract execution if the Bidder is awarded the contract, including any success fees payable.

1.4 Submission of Bids

1.4.1 The Bid prepared by the Bidder, as well as all correspondence and documents relating to the Bid exchanged by the Bidder and the CEYPETCO shall be written in English Language. The officer who signs the Bid (authorized officer) shall have proper authority from the respective Bidder or the Principle for signing all documents related to the Bid. The authority shall be in the form of a Board Resolution or documented decision of the partners in a partnership as the case may be.

1.4.2 Completed offer sheet ('Schedule B: Format of Offer') properly signed and sealed/stamped in each page will be treated as the main part of the Bid together

with other details requested in Clause 1.3 in Section 1: 'Documents and Details to Accompany the Bid' in respect of this Bid. In addition, all pages in all other documents submitted with the bid shall be initialed by the authorized officer of the Bidder.

1.4.3 All Terms and Conditions of the CEYPETCO Bidding Document and the Offer submitted by the Bidder will be an integral part of the BIMCO TIME CHARTER PARTY FOR OFFSHORE SERVICE VESSELS 2005 (Code Name: SUPPLYTIME 2005).

1.4.4 Bids shall be submitted in duplicate as per the conditions specified in this Bidding document at the address specified in Sub Clause 1.6 of Section 1. The Original and Duplicate of the Bid shall be placed in separate envelopes marked 'ORIGINAL' and 'DUPLICATE' respectively. Both envelopes shall be enclosed in one securely sealed cover and marked 'BID FOR TIME CHARTER OF MAINTENANCE AND EMERGENCY RESPONSE VESSEL (MERV) FOR CEYLON PETROLEUM CORPORATION – B/63/2026 on the top left hand corner with the statement 'DO NOT OPEN BEFORE 1400 hrs. on 20.10.2026.

1.5 Period of Validity of Bids

Bids shall be valid for a minimum period of Hundred and Nineteen (119) days (i.e up to 15.02.2027) from the closing date of the Bid with the provision to extend if necessary. The bids valid for a shorter period will be rejected as non-responsive.

1.6 Closing of Bids

Bids sealed and addressed as aforesaid shall be sent under registered cover to reach

Not later than 1400 hrs. Sri Lanka local time on 20.10.2026. If the Bidders or their representatives choose not to send their bids under registered cover they could deposit such bid in the Bid Box provide for this purpose at the office of the **Manager Procurement & Stores**, in the above address.

Any Bid received after the deadline prescribed above will be rejected and returned unopened to the Bidder.

1.7 Opening of Bids

Bids will be opened immediately after closing time at the address given in the Sub Clause 1.6 of Section 1 and Bidders or their authorized agents will be permitted to be present at the time of opening of Bids, if they so desire.

1.8 Bid Security

1.8.1 Bidders shall submit along with their Bid or prior to submission of their Bid, an Unconditional, On-demand Bid Security in the form of a Bank Guarantee as per format annexed (Please see 'Form A – Format of Bid Security' of the 'Schedule C: Standard Forms') for US\$ 40,000 (United State Dollars Forty Thousand) or LKR 13,200,000 (Sri Lankan Rupees Twenty-two Million and Five Hundred Thousand) from a commercial bank operating in Sri Lanka approved by the Central Bank of Sri Lanka (CBSL) or a Bank based in another country but confirmed by a Bank operating in Sri Lanka approved by the CBSL valid for hundred and forty-seven (147) days from the date of closing of the Bid valid up to **15.03.2027**, with the provision to extend if necessary. Bids submitted with Bid Security not in accordance with the given format of Form A of Section 8, shall be rejected.

1.8.2 The Bid Security may be forfeited:

- a) if the Bidder withdraws the Offer after Bid opening during the period of Bid validity; or
- b) if the Bidder fails to accept the award within the stipulated time referred in Sub Clause 2.1.1; or
- c) if the vessel offered is found not conforming to the agreed bid specifications upon inspection prior to delivery by the representative/s nominated by CEYPETCO, or if the delivered vessel does not conform to the agreed Bid specifications
- d) if the Bidder does not accept the correction of the Bid price, pursuant to Clause 1.10 of Section 1; or
- e) in the case of a successful Bidder, if the Bidder fails within the specified time limit to:
 - i. sign the contract; or
 - ii. Furnish the required Performance Security.

1.9 Evaluation Criteria

1.9.1 Eligibility Criteria

1.9.1.1 The service provider shall be a company/consortium duly registered in Sri Lanka or in any other country having excellent track records in the relevant field.

1.9.1.2 All of the following documents must be submitted with the Bid for the bid to be eligible for evaluation;

- i. Duly certified and signed "Form of Bid".
- ii. Duly certified and signed "Offer Sheet".
- iii. All documents and details to accompany the Bid as specified under sub clause 1.3 of the Section 1.
- iv. Bid Security in the format specified in the Form A under Schedule C.
- v. If the bidder is a Joint Venture (JV), the intended parties shall submit the letter of intention to form the JV along with their Bid and the documentary proof of the registration of the JV at the time of awarding if selected as the successful bidder.
- vi. Documentary proof of authority for signing the Bid documents by the signatory of the Bid documents and documentary proof of authority required for any other requirements specified under this bidding document.

1.9.1.3 All pages of the Bid documents to be initialed by the authorized signatory to the Bid document.

1.9.1.4 The company or any member of the consortium shall be free from any lawsuit(s) against the Company at present regarding the services offered by them.

1.9.1.5 The service provider shall be able to provide vessel(s) class with a member of IACS and possess valid ship's statutory and other Mandatory certificates and shall have comprehensive valid insurance covers for the required services.

1.9.1.6 Bidder's previous experience in owning/operating tugs shall meet the minimum requirement of 3 years with reputed clients.

1.9.2 Technical Evaluation Criteria

- i. All technical Parameters and minimum requirements specified in the Bidding document have to be met by the Bidder.
- ii. Conformance to the minimum Time Charter period of Twenty-Four (24) months with provision for extension of twelve (12) months in full or in part as determine by CEYPETCO.
- iii. Conformance to the Vessel Registration requirements of the Bidding document.

- iv. Ability of the Bidder to deliver the vessel on the date specified in the Bidding document.

The offer complying with all of the above Eligibility and Technical Evaluation Criteria will be treated as substantially responsive bids for financial evaluation.

1.9.3 Financial Evaluation Criteria

- i. The Bidder's annual turnover shall be at least LKR 500 Million / USD 1.5 Million during the last three financial years to establish the financial capability of the bidder.
- ii. The financial evaluation will be based on the total cost of operation of the vessel comprising the following costs computed using the rates quoted by the bidder;
 - a. Cost of Time Charter hire for 731 days.
 - b. Cost of 2760 meals per year
 - c. Cost of 672 accommodations per year.
 - d. Cost of Fuel Consumption for operation of the vessel at 85% Maximum Continues Rating (MCR) for 28,000 hours
 - e. Cost of mobilization and demobilization (if applicable)

(Above operational data are based on the averages during last 24 months of operation of vessels engaged in same operations)

- iii. Evaluation of the bids with respect to the bunker consumption will be based on the 85 % MCR rating provided by the bidder. The data on bunker consumption shall be verified by conducting field tests at the time of inspection stated in clause No. 2.9 (Inspection of the vessel) in Section 2. The cost of such testing shall be on bidder's account.
- iv. The lowest quoted Bid out of the substantially responsive Bids will be selected as the successful Bid.

1.10 Corrections of Arithmetical Errors

Bid/Proposal shall be checked for arithmetical errors, if any, to ensure that stated quantities and unit prices related to such quantities are consistent. The quantities shall be same as that stated in the Procurement Documents. The total Bid/Proposal price shall be the total of all line items.

The total of the line items shall be the figure reached by multiplying quantities by the relevant unit rates or the lump sum that is quoted. If there is a discrepancy between quantities, unit rates and corresponding totals, such discrepancies shall be corrected.

In case of Lump Sum contract, if there is a discrepancy between the total bid price and the price quoted under each column in the price schedule, the column price shall prevail in correcting the arithmetical errors.

The correction of arithmetical errors shall be done based on the following principles;

- i. Where there is a discrepancy between the amounts in figures and in words, the amount in words will prevail;
- ii. Where there is a discrepancy between the unit rate and the line-item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will prevail;
However, if there is an obvious gross misplacement of the decimal point in the unit rate, in which case the line-item total as quoted will prevail and the unit rate will be corrected by editing digits which confirm to the line-item total; and
- iii. After arithmetical correction, if there is a change in the Bid/Proposal price, the amount stated in the form of Bid/Proposal shall be adjusted and shall be considered as binding upon the bidder.

If a Bid/Proposal price of any Bid/Proposal is adjusted as above, the PC/BEC shall give a detailed explanation in the PC/BEC Report concerning the adjustments made.

1.11 Right of the HLPC to Accept or Reject any or all Bids

1.11.1 HLPC will not be bound to make the award to the Bidder submitting the lowest offer.

1.11.2 The HLPC reserves the rights to accept any Bid or to reject any or all Bids without adducing any reason.

SECTION 2 – CONDITIONS OF CONTRACT (COC)

2.1 Performance Security

- 2.1.1 The Successful Bidder shall inform CEYPETCO of the acceptance of the award of the Bid within four (04) working days from date of award.
- 2.1.2 Upon acceptance of the Bid, CEYPETCO reserves to itself the right to request a Performance Security (Unconditional, On-Demand) as per format annexed (please see 'Form B – Format of Performance Security' of the 'Schedule C: Standard Forms') from the successful Bidder for a sum up to 5% of the total estimated value of the contract to be established within fifteen (15) working days from date of award of Bid.
- 2.1.3 The Performance Security shall be issued in favour of CEYPETCO by a commercial bank operating in Sri Lanka approved by the CBSL or a Bank based in another country but confirmed by a Bank operating in Sri Lanka approved by the CBSL to cover the performance by the successful Bidder of the terms and conditions of award of the Bid.
- 2.1.4 Such Performance Security shall be valid for a period of hundred and ten (110) weeks from the date of the Letter of Award with an extension for another fifty-two (52) weeks. Any extension to the Charter Party shall be covered by a similar Performance Security in the same format. The successful Bidder shall forego any sum within the value of the performance security claimed by CEYPETCO to cover the losses in the event of non-fulfillment of the contract entered into or violation of any of the terms and conditions on the award of the Bid. Claim on the performance security shall be entertained by the Bidder's bank as aforesaid if they are received within a period of 30 days beyond the period of its validity (grace period of 30 days).
- 2.1.5 The successful Bidder upon notification of award, and submission of the Performance Security, shall enter into a Contract Agreement with CPC, as stated in sub clause 2.8.1 of section 2.

2.2 Mode of Payment

- 2.2.1 Time Charter hire and other payments shall be paid after deducting the local agent's commission, as stated in sub clause 2.7.4 of section 2. All dues pertaining to the vessel are as per charter party and any taxes on the vessel shall be payable by the Service Provided.

- 2.2.2 The Service Provider shall submit monthly invoices to CEYPETCO at the end of each month. Payments will be made within thirty (30) days after acceptance of the invoice by CEYPETCO.
- 2.2.3 All payments will be made to the Service Provider in US\$.

2.3 Date of Delivery and the Time Charter Period of the Vessel

The date of delivery of the vessel in Colombo (i.e. commencement of Time Charter) required by CEYPETCO will be at 1000 hrs on 01.12.2026. Vessel in substantial conformity with the Bid requirements shall be delivered by the required date by the Service Provider and the Time Charter period of the vessel will be Twenty-four (24) months.

CEYPETCO reserves the right to extend the Time Charter up to a maximum of twelve (12) months in full or in part as determined by CEYPETCO, on the same terms and conditions subject to approval of the relevant authority. The intention to exercise the said right by the charterer shall be officially communicated to the owner at least thirty (30) days before the expiry of the Charter Party. CEYPETCO reserves the right to terminate the Charter Party earlier than Twenty-four (24) months as per the provisions in Clause 31 of Part II of the BIMCO TIME CHARTER PARTY FOR OFFSHORE SERVICE VESSELS 2005 (Code Name: SUPPLYTIME 2005). The redelivery of the vessel to the owners will be at Colombo after completion of the Charter Period.

2.4 Requirements for the Vessel

- 2.4.1 The vessel shall have appropriate class notation to carry out the work specified in the bidding document. All certificates listed in item 10A of 'Schedule B: Format of Offer' shall be available on board the vessel and these certificates shall be authenticated by a member of society of International Association of Classification Societies (IACS). Certified copies of such documents shall be submitted with the Bid.
- 2.4.2 The vessel shall be capable of performing the following duties:
- a) Transferring personnel and equipment between shore and tanker/SPBM.
 - b) Handling floating hoses and transferring them to and from tanker and shore.
 - c) Maintenance of Pipe Line End Manifold (PLEM), submarine pipeline, buoy and hoses.
 - d) Provision of and storage for anti-pollution equipment and chemicals.
 - e) Keeping a tanker of max., 180,000 DWT off buoy by pulling or pushing from both bow and stern of the tanker.
 - f) Towing arrangements to be available at both bow and stern of the tug.

- g) Inspection, installation, repair & maintenance, removing, towing, loading and unloading from the MERV of both floating and under buoy hoses

- 2.4.3 The vessel shall have tug like maneuvering capabilities for tanker mooring operations and have rounded hull with robust fendering for alongside work with tankers. The bow configuration shall be rounded. In the case of pointed bow the Bidder shall provide adequate protection by a fendering arrangement, which shall not hinder any of the operational requirements of the tug. This fendering arrangement shall be to the satisfaction of CEYPETCO so that the tug could be used for pushing other vessels.
- 2.4.4 The vessel shall be available to the Charterer or their nominees to perform any other duties inclusive of carriage of cargo within its limits of capability in Sri Lanka Exclusive Economic Zone (EEZ) and work pertaining to any other SPBM.
- 2.4.5 The vessel offered shall conform to the specifications stipulated in 'Section 3: Specifications of the Vessel' and 'Schedule B: Format of Offer' at the time of delivery on the date required by CEYPETCO. Individual Bids shall be submitted on separate offer sheets obtained from CEYPETCO with separate Bid Bonds if the Bidder is offering more than one bid. Please attach the copy of the receipt of payment pertaining to obtaining each such document to the offer sheet.
- 2.4.6 In the Bids for the Time Charter, the Bidder shall be the owner or have purchase agreement with the owner or Time Charterer by demise or Manager of the Vessel offered. All necessary documentary proofs required to be submitted along with the bid. The Charter Party shall be signed only with the owner or Demise Charterer or Manager of the vessel.
- 2.4.7 Whenever the vessel offered is not available during the period of the Time Charter on account of repairs or other reasonable causes for the purpose of services required (excluding Force Majeure), the Bidder shall be obliged to provide a suitable substitute vessel acceptable to CEYPETCO in time without additional cost to CEYPETCO, so that, the services to be rendered by the vessel offered will not be disrupted. However, substitution will not be permitted at the beginning of the charter.
- 2.4.8 In the event of failure by Bidder to make available a suitable substitute, CEYPETCO reserves to itself, the right to make alternative arrangements in order to obtain a suitable vessel to continue the services. In such a case, the Bidder shall reimburse CEYPETCO with all expenses including consequential losses incurred as a result of the alternative arrangement.

- 2.4.9 Maintenance time will be as per "BIMCO TIME CHARTER PARTY FOR OFFSHORE SERVICE VESSELS 2005 (Code Name: SUPPLYTIME 2005)" with minimum twenty four (24) hours prior notice to CEYPETCO for such maintenance time. Maintenance time cannot be claimed under any circumstances during operational period of discharge of crude oil/refined products from tanker by the respective SPBM.

2.5 Time Charter Rate

The offer shall indicate clearly Time Charter Rate per day in United States Dollars, for Twenty-four (24) months. Rates for providing meals and accommodation per-head basis, to personnel other than the crew members, as required by CEYPETCO shall be stated separately for the aforesaid time charter period of the vessel. (Please see Item No. 7 (I) and Item No. 22 of the 'Schedule B: Format of Offer')

2.6 Fuel Consumption & Specifications

- 2.6.1 The consumption of fuel and the specific fuel consumption as per engine manufacturer's data as well as the current fuel consumption of the vessel shall be given at the following modes of operation stated in item 6. F.2. of 'Schedule B: Format of Offer'.

- a) Full engine power, 100% MCR fuel per day in MT
- b) Sailing, 85% MCR fuel per day in MT
- c) Idling, with generator running, fuel per day in MT

The Bidder shall submit a copy of the vessel's latest fuel consumption test certificate by an acceptable classification society along with their bid (in case Bidder submit an older Fuel Consumption Certificate along with the bid, they shall perform a Fuel Consumption test prior to awarding of contract if selected as the successful bidder and the Certificate of the same shall be available when the vessel being inspected at the time of inspection stated in clause No. 2.9 (Inspection of the vessel) in Section 2. This document shall be certified by one of the classification societies listed in item 9 A of 'Schedule B: Format of Offer', or by a competent authority acceptable to CEYPETCO.

CEYPETCO will provide only the bunker fuel requirements of the vessel at no cost to the owner and all other consumables including fresh water, lubricants etc. of the vessel shall be provided by the owner.

The specifications of the fuel supplied by CEYPETCO shall be as specified in 'Schedule D: Ceypetco Standard Specification of Bunker Fuel' of the Bidding Document. However, CEYPETCO reserves the right to revise the Bunker Fuel

Specifications from time to time if it deems necessary for better performance of the vessel.

- 2.6.2 In the event vessel consumes bunker fuel in excess of consumption stated in item 6. F.2. of 'Schedule B: Format of Offer' during the period of the contract, the cost of excess fuel consumed shall be recovered at the prevailing bunker fuel rate from the time charter payment at CEYPETCO's option. If any balance stock noticed during the bunker survey due to less consumption, that amount will be adjusted with the subsequent bunker fuel supply.
- 2.6.3 The Service Provider has to provide monthly statements of actual bunker fuel consumed for each month at different modes of operation indicated above within one (01) weeks after the end of each month from the commencement of Time Charter on the format specified by the CEYPETCO as 'Form C – Format of Bunker Consumption and Operational Report' in 'Schedule C: Standard Forms'.
- 2.6.4 The Service Provider shall make necessary arrangements for CEYPETCO representative/Government Surveyors to go on board the vessel and inspect including official log book, deck and engine log book and oil record book, bunker soundings and other relevant documents when required by CEYPETCO during the period of Time Charter including extension period, if any.

2.7 Other Conditions

- 2.7.1 CEYPETCO reserves to itself the right to communicate with any party mentioned in the offer for reference/clarifications.
- 2.7.2 The Service Provider shall not assign, sublet or mortgage its obligations or rights under any contract entered into with CEYPETCO without the express written prior approval of CEYPETCO and any such assignments, subletting or mortgage made without such approval of CEYPETCO shall be of no avail against CEYPETCO.
- 2.7.3 Bidder shall at the time of Bidding provide all valid certificates required by the Bidding Document as specified in item 10A of the 'Schedule B: Format of Offer', in respect of the vessel offered and ensure that certificates are valid throughout the period of contract (certification of validity to be as per Sub Clause 1.3.1.5 of the Section 1).
- 2.7.4 Bidders may submit Bids or proposals without local agent(s). In the case where a Bidder uses a local agent(s), Bidder shall furnish all the information/documents required as per Sub clause 1.3.2 of the Section 1 (Required Information and Documents Pertaining to Local Agents). The local agent's commission if any shall be deducted from the payments made to the Bidder and paid in Sri Lanka Rupees by CEYPETCO to the local agent(s) on account of the Bidder.

2.7.5 CEYPETCO may have sole discretion to terminate the contract with a four (04) months' notice, if the supplier's service is **not satisfactory**.

2.8 Applicable Charter Party and Governing Law

2.8.1 The successful Bidder shall enter into a Time Charter contract with CEYPETCO for the period of Twenty-four (24) months commencing from 1000 hrs on 01.12.2026 The Charter Party for the Time Charter to be used for the contract will be "BIMCO TIME CHARTER PARTY FOR OFFSHORE SERVICE VESSELS 2005 (Code Name: SUPPLYTIME 2005) (Schedule F of this Bidding Document) as amended in Section 4 of the Bidding document. The third party liability coverage under Paragraph 3 Annex B to SUPPLYTIME 2005 Charter Party shall include CEYPETCO / Ceylon Petroleum Storage Terminal Limited (hereinafter referred to as CPSTL) employees engaged in operational duties onboard the vessel.

2.8.2 The Bidder shall comply with and conform to all laws of Sri Lanka in executing its operation. Arbitration if any, arising from the Charter Party shall be governed by Sri Lanka Laws and the venue of arbitration shall be Colombo, Sri Lanka.

2.8.3 All provisions of this Bidding Document and contract to be signed shall be subject to standard Force Majeure conditions as specified in BIMCO Supply Time Charter Party 2005.

2.9 Inspection of the Vessel

2.9.1 Offered vessel will be inspected by an inspection team comprising an Expert Engineer/Mooring Master from CPSTL & a representative from CEYPETCO, prior to award of the contract. This inspection shall include testing of the vessel for confirmation of the fuel consumption stated in the bidding document. All expenditure pertaining to the said inspection (i.e. air travel, hotel accommodation, meals etc.) will be borne by CEYPETCO. Bidders shall provide necessary assistance for such inspection.

The data on bunker consumption shall be verified by conducting field tests and the cost of such testing shall be on bidder's account

2.9.2 In the event that modifications are required as per CEYPETCO specifications, the vessel will be inspected again by two representatives after carrying out necessary modifications and installation of specified equipment on the vessel prior to signing the Charter Party. All the expenditure pertaining to the said inspection or subsequent inspections of the vessel (i.e. air travel, hotel accommodation, meals etc.) shall be borne by the Bidder.

SECTION 3 – SPECIFICATIONS OF THE VESSEL

PART 1: MANDATORY SPECIFICATIONS OF THE VESSEL

The vessel shall comply with the following requirements

3.1 DIMENSIONS

- a) Length overall shall be a minimum of thirty five meters (35m) and not more than sixty meters (60m).
- b) Breadth moulded shall be not less than ten meters (10m).
- c) Depth moulded shall be not less than four meters (4m).
- d) Length between the main winch and stern to be in approximately fifteen meters (15m) or higher which ever justifiable for the Technical Team of CEYPETCO. General arrangement plan of the vessel to be submitted along with the Bid.
- e) The vessel shall have a stern roller or rounded stern flush with deck and a rounded hull. All conditions of the sub clause 2.4.3 of section 2 shall be met.

3.2 PROPULSION

Twin screw propulsion system – with main engines developing a total BHP of minimum 3000 (Three Thousand) continuous rating.

3.3 BOLLARD PULL

The vessel's continuous static bollard pull shall be not less than 40 MT at 100% MCR.

The Bidder shall submit a recent (not more than 3 months from date of closing of Bid) copy of vessel's certified Continuous Static Bollard Pull Certificates (in case Bidder submit an older Bollard Pull Certificate along with the bid, they shall perform a Bollard Pull test after awarding and submit the Certificate of the same. This document shall be certified by one of the classification societies listed in item 9 A of 'Schedule B: Format of Offer', or by a competent authority acceptable to CEYPETCO.

3.4 **BOW THRUSTER**

Bow thruster developing 3 – 7 MT of thrust at continuous rating and Bow Thrusters shall be not less than three hundred (350) BHP. Bow thruster to be operated independent of all other machinery.

3.5 **SPEED**

Vessel's economical speed shall be 8 (eight) to ten (10) knots without towage.

3.6 **FUEL CONSUMPTION/CAPACITY OF TANKS**

Capacities of bunker tanks and fuel consumption rates, under different modes of operation, to be stated as per Sub Clause 2.6.1 of 'Section 2: Conditions of Contract'.

3.7 **GENERATORS**

Generator/s with sufficient power to work all deck equipment simultaneously to be provided. Capacities of all generators and electrical load powers to be stated. 230 volt and 400 volt power outlets must be available and number of each type of outlets to be specified. The power outlets to be available outside the super structure (There shall be not less than 200 kW, 400 V, 3 phase reserve power capacity of the power system for Charterers use when bow thruster is not operational to operate external pump or air compressor.). Power supply shall be of 400 volt three phase 50 Hz.

3.8 **DECK REQUIREMENTS**

- a) Deck shall have
 - i. Sufficient area for work space & storage of maintenance tools, SPBM spares such as ropes, wires, shackles, etc.
 - ii. Deck space shall be available for storage of anti-pollution equipment (booms, skimmers, and power packs), air compressors, welding & diving equipment.
- b) Main deck winch:

Minimum twenty five (25) MT capacity continuous rating.

c) Tugger winch:

Two (02) Nos. Tugger winch of min. five (05) MT continuous rating each to be provided. Tugger winches shall be located on the main deck on port and starboard side closer to the ship's side. Mode of operations should be stated (electric, hydraulic etc.).

d) Forecastle head winch and bollards: to handle tail hose and ropes.

e) Forecastle bollards shall be of sufficient strength to pull 180,000 DWT tanker off the buoy.

f) Adequate lighting for work on forward deck and aft deck and two (02) Nos. ten inch (10") diameter search lights of not less than 2 Kilo Watts (kW) hallogen or equivalent.

g) Accommodation/Meal requirements:

i. 2 x2 berth cabin minimum

ii. Rates for providing meals/ accommodation per head basis to be stated separately (Please see item No. 22 of the Schedule B: Format of Offer).

h) Adequate storage space for SPBM maintenance equipment and materials.

i) (1) An opening with lockable gate to be provided on both port and starboard sides of the main deck bulwark.

(2) Gang plank or brow for safe access.

(3) Pilot board platform on either side (port and starboard) to allow CEYPETCO staff to board tanker using ship gangway.

(4) 03 Nos., portable communication equipment with all marine channels to be provided.

(5) Anchor handling system:

System shall be available for anchor handling and towing operations. Preferably a unit having towing pins complete with flaps for horizontal locking and fork (jaw type). Complete system (Fork and pins) shall run

vertically up and down and inserted to the deck structure. System shall be powered by high pressure hydraulic cylinders of about 200 bars.

Note: System shall be capable of handling 3" (76 mm) to 3 ½" (90 mm) diameter anchor chains and minimum load capacity of the system shall be equal to bollard pull power of the vessel.

- j) Proper manning with 3 certified (certification acceptable to Sri Lankan Registry), watch keeping officers and manning as per manning certificate.
- k) Medical First-Aid kit and equipment in accordance with WHO requirements.

3.9 BOW ANCHORS: 02 Nos.

3.10 FIRE FIGHTING EQUIPMENT

Fire monitor with high pressure firefighting pump to be available on board for immediate use in case of an external fire at a minimum distance of 20 Meters. Foam facility to be provided. (At least FiFi-1 is mandatory)

3.11 BRIDGE EQUIPMENT

Vessel shall be fitted with the following bridge equipment, which shall comply with minimum SOLAS requirements:

1. GMDSS radio console (for A1+A2+A3) and three sets of hand held two-way VHF radio telephone, with rechargeable batteries + battery chargers.
2. Magnetic compass and gyrocompass
3. At least one set of operational Radar, of minimum 24 nautical miles range.
4. Echo sounder with recorder
5. GPS navigator
6. NAVTEX receiver.
7. AIS receiver
8. Anemometer with recorder and printing facilities.
9. Computer system with printer of capacity acceptable to the charterer.

3.12 ISM/ISPS REQUIREMENTS

Vessels shall have ISM/ISPS certification.

3.13 REGISTRY

The vessel shall have Sri Lankan Registry or parallel registration in Sri Lanka during the Total Time Charter period. The parties without Sri Lankan Registry or parallel registration in Sri Lanka can submit their bids and participate in the tender, however the bidder shall arrange to register for the total time charter period upon being selected as the successful bidder before commencing operation.

PART 2: ADDITIONAL SPECIFICATIONS OF THE VESSEL

The vessel shall comply with the following specifications in addition to the above.

3.14 AGE OF THE VESSEL

Only vessels with a Builder's Certificate dated on or after 01.01.2013 shall be considered under this procurement.

3.15 SLOP TANK

Slop tank of min. 10 cubic meters capacity shall be available and suitably arranged to receive oil spilled on deck or skimmed oil and fitted with suitable discharge pump. Slop tank to have flange opening on deck to receive oil.

CEYPETCO will provide bladder type floatable tanks for the storage of spilled oil or skimmed oil.

3.16 ADDITIONAL DECK REQUIREMENTS

It is preferred if the following requirements are available in the vessel. However, If not available in the vessel at the time of bidding, the supplier shall arrange the following before commencing the service upon being selected as the successful bidder.

- a) 'A' Frame:

- i. Articulated 3 MT SWL 'A' frame at stern located on deck. 'A' frame and attachments shall be collapsible to deck level.
 - ii. 'A' frame to be designed to accommodate work close to tanker.
 - iii. 'A' frame shall be capable of working to a minimum of two and a half meters (2.5m) outward from stern end of the vessel.
- b) Inflatable run-about:

Minimum 01 No. inflatable run-about/boat to accommodate a minimum of six persons safely with life jackets with a 25–40 HP petrol outboard motor, which shall comply with all appropriate SOLAS compliance requirements. Petrol shall be provided by the Bidder.

c) Anti Pollution Equipment

- i. Spray Booms of minimum length seven point five (7.5) meters with five (5) numbers nozzles for each spray boom to cover the entire swath on both port and starboard sides, independent pumps and tanks with a minimum capacity of 4,000 liters for the storage of dispersant to be provided. A stand by pump or provision to couple the main fire pump/ emergency fire pump to the spray booms in case of failure of the main pump shall be provided. Spraying capacity shall be min. 150 liters/min as an over-the-bow spraying system. Additional hand-sprayers to be provided. Spray system shall have facility to draw direct from dispersant drum.
- ii. One number of Weir type skimmer shall be available onboard the vessel (specifications shall be compatible with the type of oil used in both the vessel offered and the Tankers handled).
- iii. One number of 'U' shape oil containment boom and Jib Arm shall be available onboard the vessel.

d) Air compressors and other equipment:

Air compressor 7 kg/cm² x 21.5 cubic meters per minute, together with one number of 2" (two inch) diameter hose of 25 meter length and 1" (one inch) diameter hose of 75 meter long, to be provided complying to the following specifications;

–An air dryer is recommended, especially in humid or outdoor environments.

–Maximum particle concentration: 8 mg/m³.

Welding equipment up to 300 amp and oxy-acetylene cutting facility to be provided.

A separate compressor (**capacity 210 liters per minute at 225 bars with power not less than 5 HP**) for charging aqua-lung bottles to be provided complying to the following Specifications;

EN 12021:2014 – Breathing Air Quality Standard

Parameter Requirement

Oxygen (O₂): 20% to 22%

Carbon Monoxide (CO) ≤ 5 ppm

Carbon Dioxide (CO₂) ≤ 500 ppm

Oil (including mist and vapor) ≤ 0.5 mg/m³

Water Vapor Pressure dew point must be at least 5°C below ambient; for compressed air at >40 bar, dew point must be ≤ –11°C

Particulates: No specified ppm, but must not cause harm or obstruction

Odor: No abnormal or noticeable odors

Toxic/Other Gases shall not be present in concentrations hazardous to health or affecting the performance of the equipment

Air quality must be tested periodically
