SUB CLAUSE NO. 2.25.2 UNDER THE CLAUSE "2.25 SUBMISSION OF BIDS" OF ABOVE TENDER NOTICE (NO: CE/0100) SHOULD BE AMENDED AND REPALCED AS FOLLOWS;
