Application Forms for registration could be obtained from my office on submission of a written request and a non-refundable cash payment of Rs. 300/= (i.e. 277.78 +8% VAT) for each category of Services.

Only the Garages/ Service Centers Located in Western Province can be registered under item No. 2 & 3.

Due to the Covid-19 pandemic, both application forms for registration could be downloaded from CPC official web site www.ceypetco.gov.lk/public_tenders and all the payments can be made to the Account No. 004100110208633 of Ceylon Petroleum Corporation at People’s Bank (Head Office).

Please submit the original of the bank deposit receipt along with the registration application.

Suppliers / Contractors who have already registered with the Corporation for the year 2021 also should re-register with the Corporation for the year 2022. Quotations for Supplies and Services will normally be called from the list of Registered Suppliers / Contractors. However, Ceylon Petroleum Corporation reserves the right to obtain quotations and make purchase / services from other non-registered Suppliers / Contractors, as well.

All applications duly completed should be hand delivered or sent by Registered Post with the letter issued from the Commissioner of Inland Revenue Department regarding the payment of Value added Tax (VAT) to reach the Manager (Procurement & Stores), Ceylon Petroleum Corporation, No. 609, Dr. Danister De Silva Mawatha, Colombo 09, **on or before 1600 hrs. on 30th November 2021.**
